

- The Council accepted the membership transfers of Deb De Boer from Living Water Community Church and of Lanae Kroeze from Carmel Reformed Church.
- Church Order Article 57 was reviewed. Adults who have not been baptized shall receive holy baptism upon public profession of faith. The form for the Baptism of Adults shall be used for such public professions.
- Committee reports were given. Mission Emphasis
   Week is scheduled for March 9-16 with the theme of God's Heart for Nations.
- The financial report for December 2024 was reviewed.
- The Council approved a Seminary Internship Program where our church has the opportunity to train, encourage, build up and shape seminary students for life-long productive ministry. This is normally a 10 week summer internship. We will wait to hear of any possible seminary students interested in our church.
- The Council approved Mission, Vision, Ministry Strategy and Principles statements for our church. These statements will be presented to the congregation through sermons and adult Sunday school classes.
- The Council approved three related overtures to Classis Heartland for educational materials in training all officebearers including a study of the Covenant for Officebearers, the Creeds and Confessions, church structure, and the ministry tasks for their particular office.

She then went to Northwestern College in Orange City for one year before moving to Volga, South Dakota, where she taught intermediate school for a couple of years.

On June 6, 1956, she was united in marriage to Julius De Jong in Ireton. They made their home in Orange City until 1966, when they moved to Rock Valley. There they were members of the Calvin Christian Reformed Church and Priscilla helped with cleaning at Hope Haven. In 1976, the family opened the Towne House Restaurant, where Priscilla was a cook until 2000. Julius passed away on May 26, 1989, in Rock Valley, after more than 32 years of marriage.

On June 17, 2000, she married Otto Alvin Huizenga in Rock Valley, and they made their home in Orange City, where they were members of the First Christian Reformed Church.
